**GENERAL ORDER OF THE
PRESIDING JUDGE**

EMER ORDER 46

17 On March 4, 2020, Governor Gavin Newsom proclaimed a state of emergency in
18 California as a result of COVID-19. On March 13, 2020, former President Trump
19 declared a national emergency in the United States due to COVID-19. Since the states
20 of emergency were declared, State and County public health officials have issued
21 guidelines and mandates targeted at limiting the spread of COVID-19 and its variants.

22 The State received its first doses of COVID-19 vaccines in mid-December 2020
23 and the rate of COVID-19 infections and COVID-19-related deaths diminished in the
24 spring and part of the summer months before increasing starting in July 2021. The
25 Centers for Disease Control and Prevention (CDC) attributed the dramatic increase in
26 COVID-19 infections and deaths to the Delta variant of COVID-19. The court has
27 maintained enhanced sanitization of court facilities since April 2020, but on July 6,
28 2021, in accordance with Cal/OSHA'S emergency temporary standards, the court

1 eliminated physical distancing and face covering requirements for vaccinated persons.
2 However, less than three weeks later, due to a rapid increase in COVID-19 infections in
3 San Bernardino County and among court staff, the court reinstated mandatory face
4 coverings for all persons while onsite at the court districts.

5 In November 2021, a new variant of COVID-19, Omicron, was identified in
6 Botswana and South Africa. This new variant, which the CDC describes as more
7 resistant to existing vaccines and significantly more transmissible than the Delta variant,
8 was detected in the United States in December 2021, resulting in high transmission
9 rates and increased hospitalizations nationwide. On December 13, 2021, the State
10 reinstated a mandate requiring masks to be worn in all indoor public settings,
11 regardless of vaccination status, from December 14, 2021, through January 15, 2022.
12 On January 5, 2022, due to rampantly increasing COVID cases and hospitalizations,
13 the State extended the indoor mask mandate to February 15, 2022.

14 Approximately 57% of San Bernardino County's residents are fully vaccinated
15 but the vaccination rate has remained flat for the past several months. The County has
16 experienced several spikes in COVID-19 infections and COVID-19-related deaths since
17 early July 2021 with the most recent increase occurring right after Thanksgiving and
18 continuing presently. When the court issued its last implementation order, there were
19 513,418 confirmed COVID-19 cases and 6,250 deaths attributable to COVID-19 in San
20 Bernardino County. As of February 28, 2022, the number of confirmed COVID-19 cases
21 in San Bernardino County is 565,595, representing an increase of more than 10% in
22 confirmed COVID-19 cases in just over 30 days. The recent surge in COVID exposures
23 and confirmed cases has adversely impacted court operations. Since January 3, 2022,
24 the court has experienced a fluctuating reduction in judges and staff who are unable to
25 perform their duties due to being quarantined. Further, the court is experiencing
26 substantial practical challenges associated with scheduling and managing criminal jury
27 trials and other criminal-related proceedings due to extreme shortages of court
28 reporters and Sheriff's deputies.

1 The court must balance access to justice with protecting the health and safety of
2 the public, judicial officers, staff, vendors, Sheriff's department staff, and inmates. This
3 effort is made more complicated by the fact that the court is operating with a reduced
4 budget and fewer staff and judicial officers due to COVID-related absences. Based on
5 the burdensome circumstances associated with conducting court operations during this
6 pandemic, Chief Justice Tani G. Cantil-Sakauye has issued several emergency orders
7 permitting the court to extend the original or extended dates for criminal trials by no
8 more than 30 days, and during this timeframe the court has implemented every
9 reasonable measure to bring criminal cases to trial.


10 Consequently, after careful deliberation, the Presiding Judge has concluded that
11 extending last-day deadlines for criminal trials and preliminary examinations is
12 necessary under the present circumstances. For the reasons stated herein, the court
13 finds good cause to implement the authority granted to it under California Rule of Court,
14 Rule 10.603; case authority recognizing the court's broad powers to ensure the orderly
15 administration of justice (*see e.g., Walker v Superior Court* (1991) 53 Cal.3d 257, 266-
16 267); Chief Justice Tani G. Cantil-Sakauye's March 30, 2020, and April 29, 2020,
17 statewide Orders; the Chief Justice's February 28, 2022, Emergency Order; and
18 Government Code Section 68115, and HEREBY ORDERS AS FOLLOWS:

- 19 1. Effective immediately, and in accordance with the Chief Justice's February
20 28, 2022, Order, the time for conducting criminal trials under Penal Code
21 section 1382 is extended up to an additional 30 days, applicable only to
22 cases in which the original or previously extended statutory deadline
23 otherwise would expire from March 1, 2022, through March 30, 2022,
24 inclusive. The court may conduct a trial at an earlier date, upon a finding of
25 good cause shown, or through the uses of remote technology, when
26 appropriate, and if feasible.
- 27 2. Effective immediately, and in accordance with the Chief Justice's March 30,
28 2020, statewide Order, the time period provided in section 859b of the Penal
